- 2. Approval of Minutes May 2025 Minutes agreed. KT/AG
- 3. Matters Arising and Actions from previous meeting
 - Badenoch Broadband update (AG) The update we were to provide to the meeting has been overtaken by the open event held by BB last week. Information from them has been shared.
- 4. Loch Earba Pump Hydro Storage Update (AT)
 - SSEN-T Coire Mashie SSE have now provided us with further information and maps to show
 possible access tracks to each of the proposed substation sites. This has been shared with
 the community
 - Earba Alliance An email address has been set up specifically for the Alliance group in order
 to present a united voice. A group structure is still under discussion (Chair, Sec etc) as is the
 number of attendees per Community Council. LCC will continue to attend with rotation of
 attending members as necessary.
 - Gilkes and Foundation Scotland meeting update A meeting was held at the Village Hall with Highland Council Development Officers, Earba Alliance Group and Gilkes. A representative from Foundation Scotland was also in attendance. The position of the Alliance is that we should not engage with Gilkes until we have the result of the Cap and Flow, the outcome from the government consultations to which Laggan recently responded on behalf of LCC and until a final developer has been decided. As a result of the meeting LCC will meet independently with Rachel Searle of Foundation Scotland regarding potential assistance with managing community benefits.
 - Engagement with Transport Scotland Laggan and Newtonmore CCs have issued a joint letter to Transport Scotland outlining our concerns about the condition and visibility of the roads (A86, A889) The other CCs have also written separately to TS.
 - Next steps AT will draft a letter to Gilkes as a formal follow up to the meeting.
